

2 firms to share Dover school pact

Dover board of education went through a lengthy agenda in an hour last night, then spent another hour making a decision on letting a contract for milk.

Jerry Bichsel of New Philadelphia, representing the Goshen Dairy, and Ed Hagerman of Dover, representing Superior Dairy, each asked the board's favor in letting the contract. The firms submitted identical bids of 6.9 cents per half pint for homogenized milk and 7.1 cents a half pint for chocolate milk.

The board voted to split purchases between the two as evenly as possible and asked George Aebersold, clerk-treasurer, to contact the two men and iron out contract details.

Aebersold reported he had received no quotation from Y. and O. Coal Co. pending anticipated labor contract negotiations. The bid for gasoline and petroleum products for school buses was awarded Dover Auto Supply Co.

STEVE MONACO, president of student council, outlined plans for the coming year, displayed a handbook and a number of written programs and told of work done at a three-day workshop-training program held in July in preparation for council activities when school opens.

Board members expressed their interest, offered their support and invited council to attend board meetings in an effort to develop better understanding between the two units.

Robert Schrock, high school principal, showed an architect's drawing for a bulletin board to be presented to the school by the Mothers Athletic Club. The outdoor board, about six feet long and decorated with a planter, will be used to apprise the public of special events taking place at the school. The board approved a motion to accept the board.

ON RECOMMENDATION of Supt. Bill Kinneer, the board:

—**APPOINTED** Douglas Willoughby of Dover to the teaching staff.

—**ASSIGNED** extra curricular duties as junior high football coach to David Contini and Russ McGothlin and varsity football coach to John Starnier.

—**EMPLOYED** Dr. James Houghlan as school physician and Dr. Donald Mastin as team physician.

—**APPROVED** the employment of Pauline Geiser and Donna Simmons as summer school teachers because of an increase in enrollment.

—**ACCEPTED** the resignations of Mary Klar, cafeteria manager, and Tom Conwell, auditorium manager.

—**CHANGED** the classification of Margaret Osburn from cook II to manager of the high school cafeteria and Catherine Dill from cook I to manager of the elementary cafeteria.

—**ADOPTED** the use of chemistry textbooks recommended by Paul Koval, director of curriculum, and approved the purchase of 115 copies of the book and two copies of the teachers' guide at a cost of \$676.

—**VOTED TO** continue, on the recommendation of Don Peters, executive assistant, the present fee of \$2.50 for workbooks and consumable supplies for the kindergarten and \$3.75 for other pupils.

—**APPROVED** continuation of early dismissal of elementary students every Wednesday at 2:45 for professional staff meetings and set aside six days when junior and senior high classes will begin at 9:49 to allow for morning faculty meetings. Suggested dates for the latter were Sept. 29, Oct. 27, Dec. 8, Feb. 9, March 15 and May 17.

—**APPROVED** continued participation in ESEA (Elementary and Secondary Education Act) Title I, II and III programs and NDEA (National Defense Education Act) Title III and V programs.

—**APPROVED** a substitute teachers list, bus routes set up by Peters and attendance at professional meetings for Lawrence Baker and Howard E. Denison.

—**RECOMMENDED** that, as indicated by a vote of the junior class, Troup and Pluto photography studio of Canton be offered a contract for senior class and Swirl photography for the upcoming school term.

—**DECIDED** to follow Schrock's recommendation to use a grading system of satisfactory or unsatisfactory for physical education and not to count the course toward the student honor roll.

—**ACCEPTED** Schrock's recommendation for including examination grades as a part of six-week grades instead of as separate grades.

The meeting was recessed, subject to recall for study sessions deemed necessary before the opening of school.
